**GENERAL ORDER: 2016 D 8 (SUPERSEDES GENERAL ORDER 2016 D 6)**

**SUBJECT: SCHEDULING OF IV-D CASES**

**EFFECTIVE DECEMBER 16, 2016, IT IS HEREBY ORDERED THAT:**

Pursuant to this General Order, "active cases" are defined as cases with a future court date and "inactive cases" are defined as cases with no future court date.

All active cases currently assigned to Hearing Officer Calendars shall not be continued to Hearing Officer Alpha Calendars. Rather, such cases shall be permanently transferred from the Hearing Officer Alpha Calendar to the corresponding Judicial Calendar as follows:

| <b>Calendar S cases shall be transferred to the Judicial Calendar to which the case was randomly assigned at the time of filing</b> |
| <b>Calendar Q cases shall be transferred to the Judicial Calendar to which the case was randomly assigned at the time of filing</b> |

After December 16, 2016, all newly filed IV-D cases shall be randomly assigned to the following 18 Judicial Calendars with court dates to be scheduled subsequent to February 6, 2017.


