**GENERAL ADMINISTRATIVE ORDER: 2024 D 1**

**SUBJECT: CONSOLIDATION OF THE DOMESTIC RELATIONS DIVISION IN  
SUBURBAN DISTRICTS 2, 3, 4, 5, and 6.**

**IT IS HEREBY ORDERED THAT:** Commencing August 16, 2024, the following shall be in effect for Suburban Municipal Districts 2 (Skokie), 3 (Rolling Meadows), 4 (Maywood), 5 (Bridgeview), and 6 (Markham) of the Circuit Court of Cook County Domestic Relations Division:

**Overview:** In order to better serve families and litigants in the suburban areas of Cook County, effective August 16, 2024, the Domestic Relations Divisions in Districts 2, 3, 4, 5, and 6 will no longer maintain a separate Parentage and Child Support calendar. All judges assigned to the Domestic Relations Division in these Districts will preside over both dissolution of marriage and parentage cases.

**I. New Organization of Domestic Relations Division: District 2, Skokie:**

- a. Upon consolidation, District 2 shall be comprised of one Domestic Relations Division calendar, Calendar 82. The existing Domestic Relations Division calendar, Calendar 82, shall remain as is. The existing cases on Calendar V shall be transferred to Calendar 82.
- b. Effective August 16, 2024, Calendar V shall be dissolved, and any new Domestic Relations Division case filed in District 2 shall be assigned to Calendar 82.

**II. New Organization of Domestic Relations Division: District 3, Rolling Meadows:**

- a. Upon consolidation, District 3 shall be comprised of three Domestic Relations Division calendars: Calendar 13, Calendar 83, and Calendar 93.
- b. In order to equalize the dockets, all cases filed on or after January 1, 2019, on Calendar 83, Calendar G, and Calendar W shall be randomly assigned to Calendar 13, Calendar 83, or Calendar 93.
- c. All cases filed prior to January 1, 2019, on Calendar G shall be transferred to Calendar 13.
- d. All cases filed prior to January 1, 2019, on Calendar 83 shall remain on Calendar 83.
- e. All cases filed prior to January 1, 2019, on Calendar W shall be transferred to Calendar 93.
- f. Effective August 16, 2024, Calendar G and Calendar W shall be dissolved, and any new Domestic Relations Division case filed in District 3 shall be randomly assigned to Calendar 13, Calendar 83, or Calendar 93.

**III. New Organization of Domestic Relations Division: District 4, Maywood:**

- a. Upon consolidation, District 4 shall be comprised of one Domestic Relations Division calendar, Calendar 84. The existing Domestic Relations Division calendar, Calendar 84, shall remain as is. The existing cases on Calendar X shall be transferred to Calendar 84.
- b. Effective August 16, 2024, Calendar X shall be dissolved, and any new Domestic Relations Division case filed in District 4 shall be assigned to Calendar 84.

**IV. New Organization of Domestic Relations Division: District 5, Bridgeview:**

- a. Upon consolidation, District 5 shall be comprised of two Domestic Relations Division calendars: Calendar 65 and Calendar 85.
- b. In order to equalize the dockets, all cases filed on or after January 1, 2019, on Calendar Y, Calendar 85, and Calendar 87 shall be randomly assigned between Calendar 65 and Calendar 85.
- c. All cases filed prior to January 1, 2019, on Calendar 87 shall be transferred to Calendar 65.
- d. All cases filed prior to January 1, 2019, on Calendar Y shall be transferred to Calendar 85.
- e. Effective August 16, 2024, Calendar Y shall be dissolved, and any new Domestic Relations Division case filed in District 5 shall be randomly assigned to Calendar 65 or Calendar 85.

**V. New Organization of Domestic Relations Division: District 6, Markham:**

- a. Upon consolidation, District 6 shall be comprised of three Domestic Relations Division calendars: Calendar 66, Calendar 76, and Calendar 86.
- b. In order to equalize the dockets, all cases filed on or after January 1, 2019, on Calendar H, Calendar Z, and Calendar 86 shall be randomly assigned to Calendar 66, Calendar 76, or Calendar 86.
- c. All cases filed prior to January 1, 2019, on Calendar H shall be transferred to Calendar 66.
- d. All cases filed prior to January 1, 2019, on Calendar Z shall be transferred to Calendar 76.
- e. All cases filed prior to January 1, 2019, on Calendar 86 shall remain on Calendar 86.
- f. Effective August 16, 2024, Calendar H and Calendar Z shall be dissolved, and any new Domestic Relations Division case filed in District 6 shall be randomly assigned to Calendar 66, Calendar 76, or Calendar 86.


