**GENERAL ADMINISTRATIVE ORDER NO. 2012-07**

**SUBJECT: SPINDLING CERTAIN MOTIONS ON THE POST-MEDIATION CALL  
(MORTGAGE FORECLOSURE SECTION);  
CREATION OF CALENDAR 68 AND CALENDAR 69**

The Mediation Calendars in the Mortgage Foreclosure Section of the Chancery Division need to be assigned calendar numbers so that proper transfer orders may be signed transferring cases from the trial calendar to the mediation calendar and that appropriate motions may be spindled before the judges presiding over the Mediation Calendars.

**IT IS HEREBY ORDERED:**

1. Calendar 68 and Calendar 69 are now created for the sole purpose of hearing mortgage foreclosure cases that are referred to mediation.
2. The Clerk of the Court shall allow the following motions to be spindled at the motion counter in Room 802 on Calendar 68 and Calendar 69:
  - “Motion for Substitution of Judge as of Right on the Post-Mediation Call”,
  - “Motion for Substitution of Judge for Cause on the Post-Mediation Call”,
  - “Motion to Return Mortgage Foreclosure Mediation Case to the Foreclosure Trial Call”,
  - and
  - “Motion for Sanctions Relating to Mortgage Foreclosure Mediation”

No other motions shall be spindled on Calendars 68 and 69 by the Clerk’s Office.

3. The Clerk of the Court shall allow those motions to be spindled on Calendar 68 on the following schedule:

Wednesdays at 9:00AM or 1:30 PM in Room 2806

The maximum number of motions allowed to be scheduled at those times shall be ten (10) motions.

4. The Clerk of the Court shall allow those motions to be spindled on Calendar 69 on the following schedule:


Thursdays at 9:00 AM or 1:30PM in Room 2809

The maximum number of motions allowed to be scheduled at those times shall be ten (10) motions.

5. Any attorney or litigant seeking to schedule a Motion for Substitution of Judge as of Right on the Post-Mediation Call, a Motion for Substitution of Judge for Cause on the Post-Mediation Call, a Motion to Return Mortgage Foreclosure Mediation Case to the Foreclosure Trial Call, and/or a Motion for Sanctions Relating to Mortgage Foreclosure Mediation shall present a motion entitled exactly as entitled within this General Administrative Order.
6. A motion for any other matter or a motion that does not conform with the requirements set forth shall be spindled in Room 802 by the Clerk's office on the General Mortgage Foreclosure calendar to which the case was originally assigned (i.e., Calendars 55-64).
7. When a Motion for Substitution of Judge on the Post-Mediation Call is presented on Calendar 68 or Calendar 69 in conformance with this General Administrative Order, and the motion is granted, the order attached hereto as Attachment A shall be used.
